Frequently Asked Questions (FAQs)

Who can become a member of the British Council IELTS Partnership Programme?

Any organisation that helps test takers learn English, places them in universities and/or helps them with migration procedures can become a member. Eligible organisations can also be privately-held training schools, educational institutions, support companies, venue partners and pathway providers.

How long is our membership valid for?

Programme membership is awarded based on average test taker registrations during a fiscal year and is valid for the following year. The membership status will be reviewed at the end of that period.

We have just started registering test takers with the British Council. How do we participate in the programme?

What other prerequisites must we satisfy to become a member of the British Council IELTS Partnership Programme?

All organisations that register test takers for IELTS using the British Council online registration system are required to sign an agreement with the British Council.

When and how will we receive our membership benefits?

This will depend on the location of the partnership programme(s) you are enrolled in as, apart from universal provision of few core benefits, IELTS partnership programmes differ from country to country.

What are the financial benefits that the British Council provides for online registrations?

Some programmes offer an administrative fee for each test taker you register online. The total amount due to your organisation is usually calculated on a quarterly basis at the end of March, June, September and December.

Will membership benefits be the same next year?

As we constantly seek to improve our services, the membership benefits will be reviewed periodically, taking into account the feedback from partner organisations across the world.

Terms & Conditions:

- This programme is only open to partners who have registered test takers for IELTS with the British Council
- Membership level is based on the number of registrations during a fiscal year
- Use of the British Council logo is not permitted
- The British Council reserves the right to alter, amend or cancel this programme anytime, without prior notice
